ADMINISTRATIVE MATTERS Disclosure of Potential Conflicts of Interest: The Board noted that disclosures of potential conflict of interest statements for each of the Directors were filed with the Secretary of State seventy-two hours in advance of the meeting. Attorney Becher requested that the Directors consider whether they had any additional conflicts of interest to disclose. Attorney Becher noted for the record that there were no new disclosures made by the Directors present at the meeting and incorporated for the record those applicable disclosures made by the Board Members prior to this meeting and in accordance with the statutes.

<u>Quorum/Confirmation of Meeting Location/Posting of Notice</u>: Attorney Becher confirmed the presence of a quorum.

It was noted that the District Board meeting was held and properly noticed to be held via video enabled web conference (Zoom). Following review, upon motion duly made by Director Branyan, seconded by Director Knight and, upon vote unanimously carried, the Board ratified approval of the payment of claims in the amount of \$3,012,167.97.

<u>Committee to Authorize Payment of Interim Claims</u>: Following discussion, upon motion duly made by Director Knight, seconded by Director Branyan and, upon vote unanimously carried, the Board formed a committee consisting of Directors Branyan and Knight, and authorized the committee to review and approve payment of interim claims, as needed.
